



Retail Inventory Adjustments in Sweed

Purpose

Teach retail and inventory staff to execute compliant quantity corrections in Sweed, ensuring accurate data across BioTrack and internal systems.

Learning Objectives

By the end of this course, learners will be able to:

- Identify valid adjustment reasons.
- Use standard note format and documentation.
- Verify discrepancies before editing.
- Maintain audit-ready records.



Understanding Adjustments

- Adjustments correct count discrepancies related to sales errors & distribution lot quantities.
- Four approved reasons:
 - Invoice Correction (receiving errors)
 - Oversold (+)
 - Undersold (-)
 - Incorrect Quantity (Exit Bags only)

Verification Before Adjusting

1. Recount the product physically.
2. Confirm BioTrack tag and barcode match.
3. Check all potential storage locations.
4. Use Sweed/BioTrack Adjustment Reports.

Quick Tips to Perform:

1. Swebd → Inventory → Stock Items.
2. Search product by name or tag.
3. Click **Adjust**.
4. Enter Qty Change, Reason, and Note.
5. Confirm → Audit trail records change.



Post-Adjustment Review

- Compare Sweed vs BioTrack inventory.
- Escalate repeat errors to Inventory Manager.
- Update Adjustment Report weekly.
